**IAIS to hold public background session via teleconference
on the public consultation package
on the revised ICPs and ComFrame-specific material and on the draft
Application Paper on Group Corporate Governance
[from 14:00 to 16:00 CET (Basel time)]**

A public background session will be held via teleconference on 20 March 2017 to discuss the following elements of the public consultation package on the revised ICPs and ComFrame-related material released on 3 March 2017:

- Governance:
 - ComFrame material integrated with ICP 5 (Suitability of Persons)
 - ComFrame material integrated with ICP 7 (Corporate Governance)
 - ComFrame material integrated with ICP 8 (Risk Management and Internal Controls)
- Resolution:
 - Revised ICP 12 (Exit from the Market and Resolution) and ComFrame material integrated with ICP 12

The draft Application Paper on Group Corporate Governance, released on 3 March 2017, will also be discussed during this session.

The purpose of this session is to:

- Provide background information on the documents specified in this notice.
- Outline how the project has progressed and highlight key aspects in the material that is being presented for consultation.
- Describe specific issues for which the IAIS is seeking targeted input.
- Answer questions from stakeholders that are related to the consultation.
